IMPORTANT CHANGE TO CHINA TARIFF

Farmingdale, NY – MPD (Memory Protection Devices), a leading manufacturer of battery holders and electronic components, announces proactive measures to minimize the impact of the newly imposed 170% tariff on imports from China, effective April 17 2025 (**Subject to change by the US Federal government**). These initiatives will help our valued customers avoid unnecessary costs and maintain a reliable supply chain. As per the 10% Taiwan tariff, MPD will not be passing this on to our customers.

MPD has taken the following actions to cushion the effect of this tariff for our customers:

1. **MPD has decided that it will only pass on 95% of the total 170% tariff imposed by the federal government for imports from China. The tariff will be applied only on inventory received after the effective date of April 17, 2025. Current inventory is not subject to any tariff.**
2. **Hong Kong Warehouse**
To ensure smoother, more cost-effective fulfillment, MPD has **expanded operations to a new Hong Kong warehouse**. By leveraging Hong Kong's well-established logistics network, MPD can more efficiently consolidate and ship product orders, reducing shipping times and mitigating part of the added tariff costs that directly impact U.S. customers.
3. **New York Warehouse & Correct HTS Classification**
Within the United States, MPD continues to maintain its **New York warehouse** for direct domestic shipments. Our trade compliance team regularly reviews the **Harmonized Tariff Schedule (HTS)** codes used for MPD products, ensuring that each item is accurately classified under U.S. Customs guidelines. This helps to **prevent overpayment** of duties and makes certain that customers only pay what is required by law.
4. **Commitment to Customer Success**
With a broad global network and decades of experience managing international logistics, MPD is fully prepared to handle these new tariff challenges. By **strategically positioning inventory** and **adhering to best-in-class compliance practices**, we help our customers maintain competitive pricing, consistent supply, and peace of mind—even during times of changing trade regulations.
